Further to our letter dated 27th March regarding the above proposed residential trip, we are writing to advise that unfortunately, given the limited interest in the trip, it is not currently viable on these dates.

We have, however, spoken with PGL Caythorpe Court, who have offered us an alternative weekend at a lower cost. The new proposed dates for the trip are **Friday 4th July - Monday 7th July 2025**. Should we move the proposed trip to these dates, then the cost will reduce by £50 to £255 plus VAT per child, excluding the bus.

If you have already signed your child up to take part in the residential trip, please complete the attached form to indicate if you would still like a place with the revised dates.

If, however, you would now like your child to take part in the residential visit on the revised dates, please complete and return the attached consent form by Wednesday 22nd May with your non-returnable deposit of £40.00 being paid on ParentPay by the same date. Further payment details will follow in due course once we know if the trip will go ahead. Should the trip be viable, deposits will be refunded.
